

THE NATIONAL DAY TO PREVENT TEEN PREGNANCY EVALUATION SURVEY CONTEST
OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.

This Contest is sponsored by The National Campaign to Prevent Teen and Unplanned Pregnancy ("Sponsor"), 1776 Massachusetts Avenue, NW, Suite 200, Washington, DC 20036. Contest is void where prohibited. By entering, each entrant accepts and agrees to be bound by these Official Rules. Failure to comply with these rules may result in disqualification.

HOW TO ENTER: No purchase or payment of any kind is necessary to enter or win this Contest. The Contest begins on May 1, 2017 at 12:00 AM PST and ends on May 31, 2017 at 11:59 PM PST (the "Entry Period"); Sponsor reserves the right to extend or change the Entry Period without additional notice. To enter, visit <http://www.surveymonkey.com/s/nd-survey>, complete the National Day to Prevent Teen Pregnancy Evaluation Survey, and submit a valid email address. Limit one entry per person for the duration of the Contest. All entries will be considered made by the authorized account holder of the email address. Persons with multiple email addresses must submit only one entry from one email address. Duplicate entries will be disqualified. A valid email address must be provided in order to be entered to win; email addresses will not be sold or used for any purpose other than to contact winners about claiming their prize.

All entries become the property of Sponsor, and Sponsor reserves the right to use any information submitted by entrants. Sponsor is not responsible for lost, late, illegible, misdirected or mutilated entries, including due to transmission, technical, and/or network failures of any kind, including, without limitation, malfunctioning of any hardware or software (whether originating with sender or Sponsor), human error, or any other error or malfunction. The authorized account holder of the email address submitted at time of entry will be considered the entrant. An "authorized account holder" shall mean the natural person assigned to such email account by the Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with such email account. A potential winner may be requested to provide proof that he or she is the authorized account holder of the email address associated with a winning entry.

Entrants agree not to upload, post or transmit any materials that contain any computer viruses, Easter eggs, worms, Trojan Horses or other harmful component or programming routines that are intended to damage, detrimentally interfere with, surreptitiously intercept or expropriate any system, data or personal information. ELIGIBILITY: This Contest is open only to legal residents of the United States who are between 13 and 19 years of age at the time of entry. Contest is void where prohibited or restricted by law. Employees of Sponsor and its respective parents, subsidiaries, agencies, and affiliates, and their immediate families and persons living in their households are not eligible to participate in this Contest. By entering this Contest, participants agree to abide by all terms of these Official Rules and to be bound by the decisions of the Sponsor. All federal, state, and local laws apply. Winners will be required to sign and return to Sponsor within fourteen (14) days an affidavit of eligibility and release (except where prohibited) affirming their agreement to all terms, conditions, and restrictions in these Contest rules. If the winner is a minor, then prize will be awarded to winner's parent or legal guardian.

RANDOM CONTEST DRAWING: Sponsor will conduct a random drawing on June 6, 2017, to select ten (10) Winners from among all eligible Contest entries received within the Entry Period. Odds of winning depend on the number of eligible entries received. Entrants are required to correctly complete the survey and provide a valid email address to the Sponsor upon completing the survey anytime during the Entry Period. To be valid, all entries must be received no later than May 31, 2017 11:59 PM (PST). All decisions of Sponsor concerning all matters related to this Contest are final. Winners will be notified via email by June 9, 2017. If any attempted prize notification is not successful within seven (7) days, the prize will be forfeited and Sponsor reserves the right to randomly select an alternate winner from among the remaining eligible entries.

PRIZES: TEN (10) PRIZES will be awarded. Each winner will receive one (1) \$50 Amazon.com digital gift certificate. The estimated retail value is approximately \$50.00 per prize. The winner is responsible for any and all additional costs associated with the use or enjoyment of prizes.

Actual retail value of prizes may vary. Winners will not receive difference between actual and approximate retail value. Prizes may not be exchanged or redeemed for cash, sold, or traded. No prize transfer, assignment, or substitution by Winners is permitted. Sponsor reserves the right to substitute a prize, in which case a prize of equal or greater value will be awarded. Gift certificates are digital and will be delivered electronically via email; Sponsor is not responsible for prizes that are lost or not received due to SPAM filters, invalid email addresses, returned emails, or other circumstances beyond Sponsor's control.
